
# REGIONAL QUALITY COUNCIL (RQC) NEWSLETTER

### Statewide News

The Regional Quality Councils (RQCs) work to improve the quality of services for people with disabilities. In partnership with the Minnesota Department of Human Services, 2022 was the start for a new contract for 4 Regional Quality Councils across the state of Minnesota:

- Region 10 Quality Council in Southeast Minnesota
- Metro Regional Quality Council
- West Central Quality Council
- · Arrowhead Quality Council in Northeast Minnesota

The RQCs worked hard to get staffed, re-engage their council members and recruit new council members. The councils also determined regional priorities to focus on.

All four council work together on the statewide priority of addressing the workforce shortage that creates a barrier to disabled people living the life they desire.

## Staffing Shortage

The Workforce Shortage Workgroup engaged with legislators this spring. The workgroup

- Educated them on how some of their bills would impact people with disabilities in Minnesota
- Advocated for bills that would make a positive impact

## Culture of Safety - Data Action Group

Each council, except West Central, works with the Department of Human Services in a Data Action workgroup. The purpose is to:

- Review regional critical incidents in licensed settings
- Evaluate the systemic influences that contribute to them
- Make recommendations to DHS's Culture of Safety Action Group for change
- Help organizations move from a culture of fear... to a culture of safety

West Central will start a workgroup in the fall of 2023.

ARQC added 4 new counties and 3 new members from the Iron Range with the new contract in 2022.

### Workgroups

ARQC focus is on Person Centered Practices, especially within the housing and transportation sectors.

- Develop a person-centered practices overview for specific groups of people. These groups include Direct Support Professionals from small providers, apartment managers and caretakers, transportation workers, and people with disabilities.
- Develop plain language materials on Person-Centered Thinking and Positive Behavior Supports in partnership with self-advocates in 3 different regions within the Arrowhead. We have also committed to continuing these self-advocate groups after the grant ends this summer.
- Joined the Affordable Housing Coalition and the Regional Transportation Coordinating Committee.

## Workgroups

#### Housing

- Collaborating with accessible housing councils to educate decision-makers about the challenges, and changes needed, for people with disabilities
- Explored the idea of tenant councils
- Goal is to hold an accessibility walk before the end of the year. This would include demonstrate accessibility of local business and residential buildings.

#### **Transportation**

- Worked with Rochester Public Transit to make their ZIPS (Zumbro Independent Passenger Service) paratransit application more accessible.
- Attended a training session at the Saint Cloud Metro
  Bus Mobility Training Center. They taught us how a
  transportation hub works. We learned how their personcentered process helps people get their transportation
  needs met.
- Our goal is to continue working with transportation providers to create more accessible transportation options and provide education.

#### Transition to adulthood

- Survey and focus groups to understand needs
- Transition checklist
- Information on guardianship, alternatives and supported decision making
